# **BYLAWS OF THE FLORIDA CANCER CONTROL AND RESEARCH ADVISORY COUNCIL**

## **ARTICLE I: AUTHORITY, TITLE, AND DEFINITIONS**

- 1.1 AUTHORITY: The Cancer Control and Research Act (Section. 1004.435, Florida Statutes) establishes the Florida Cancer Control and Research Advisory Council (referred to as “the Council”).
- 1.2 TITLE: These bylaws may be known and cited as the bylaws of the Florida Cancer Control and Research Advisory Council.
- 1.3 EXECUTIVE DIRECTOR: Employee designated by Moffitt Cancer Center to administer the Council.

## **ARTICLE II: LOCATION AND STAFF**

- 2.1 LOCATION: The Council office shall be located at the H. Lee Moffitt Cancer Center and Research Institute.
- 2.2 STAFF: The H. Lee Moffitt Cancer Center and Research Institute shall provide staff support and other assistance as reasonably necessary for the completion of the responsibilities of the Council. An Executive Director will be assigned to facilitate coordinated functions and assist in carry out of the duties of the Council.

## **ARTICLE III: MISSION AND PROCEDURES**

- 3.1 MISSION: In an effort to reduce morbidity and mortality associated with cancer in Florida through prevention, early detection, and state-of-the-art therapy, the mission of the Council is:
  - a. To advise the Governor, the Legislature, and state agencies on cancer control programs, policies, priorities and initiatives,
  - b. To approve a state cancer plan, and coordinate with the Biomedical Research Advisory Council on a state cancer research plan
  - c. The Council will meet in person bi annually.
- 3.2 PROCEDURES
  - 3.2.1 *Advisory Capacity*: Issues may be brought to the Council by any member or other interested person by notifying the Chairperson or the Executive Director. Recommendations shall be made in writing to the Governor, Legislators, the

Secretary of Health, or other appropriate individuals or agencies.

#### **ARTICLE IV: COMPOSITION OF THE COUNCIL**

- 4.1 COMPOSITION: Membership criteria, agencies represented, and requirements for minority representation are as specified in Section 1004.435, F.S (4)(a), Florida Statutes.

#### **ARTICLE V: NOMINATION AND APPOINTMENT PROCESS**

##### **5.1 APPOINTMENT PROCESS**

###### **5.1.1 New Appointments**

- 5.1.1.1 Organizations, the Governor's Office, the Speaker of the House's Office, and the Florida Senate President's Office shall provide the Executive Director the name of the member they wish to appoint.

###### **5.1.2 Reappointments**

- 5.1.2.1 At the end of a member's term, the represented organization shall notify the Executive Director if they wish to reappoint their current member or appoint a new one.

#### **ARTICLE VI: MEMBERSHIP RULES**

- 6.1 TERMS OF SERVICE: Organizations appoint members for a term of four years, and can be re-appointed for an unlimited number of terms.
- 6.2 RESIGNATION: A member wishing to resign before the end of his/her term shall submit a letter of resignation to the Executive Director. Organizations must immediately appoint a new member.
- 6.3 CONFLICT OF INTEREST: No member of the Council shall participate in any discussion or decision to recommend grants or contracts to any qualified nonprofit association or to any agency of this state or its political subdivisions with which the member is associated as a member of the governing body or as an employee or with which the member has entered into a contractual arrangement.
- 6.4 REMUNERATION: Council members will serve without pay per Section 1004.435, F.S. (4)(e).

**ARTICLE VII: OFFICERS**

- 7.1 CHAIRPERSON: A chairperson shall be selected by the majority of the Council for a term of 2 years. The chairperson shall appoint an executive committee of no fewer than three members to serve at the pleasure of the chairperson. This committee will prepare material for the council but make no final decisions.

The Chairperson, or his/her proxy, will liaison with other state councils and advisory boards as needed to fulfill the duties of the Council. The Chairperson may request participation by content experts or other state council/advisory members to fulfill the duties of the Council. These consultants will have no voting capacity and must adhere to the Council Conflict of Interest policy.

- 7.2 VICE CHAIRPERSON: A vice chairperson shall be selected by the majority of the Council for a term of 2 years.

**ARTICLE VIII: DUTIES OF THE COUNCIL**

- 8.1 DUTIES: The duties of the Council are outlined in F.S. 1004.435 (4)(g-m), Florida Statutes.

**ARTICLE IX: MEETINGS**

- 9.1 REGULAR MEETINGS: The Council shall meet at least twice a year. Notification of such meetings shall be at least thirty days prior to the meeting date, and shall be published in the Florida Administrative Weekly.
- 9.2 SPECIAL MEETINGS: Special meetings may be called by the Chairperson at his/her discretion upon the written request of four members of the Council. Notification of such meetings shall be at least fifteen days in advance of the meeting date.
- 9.3 QUORUM: Eight members shall constitute a quorum for the purpose of exercising the powers of the Council. A vote of the majority of the members present is sufficient for all actions of the Council.
- 9.4 EXECUTIVE COMMITTEE MEETINGS: The Chairperson shall appoint an executive committee of no fewer than three persons to serve at the pleasure of the chairperson. This committee will prepare material for the council but make no final

decisions. Meetings of executive committee members shall be noticed 10 days prior to the meeting.

- 9.5 SUBSTITUTES: If a member cannot attend a meeting, s/he may send a substitute, who is authorized to vote. The member must notify the Executive Director in writing prior to the meeting if a substitute will be attending and who the substitute will be.
- 9.6 ABSENCES: Members shall inform the Executive Director if they are unable to attend a scheduled meeting. In the event of two consecutive absences without just cause or prior notification, even if a substitute is provided, a member may be asked by the Chairperson to submit a letter of resignation. The sponsoring organization will be notified and asked to nominate another representative.
- 9.7 RULES OF ORDER: The rules contained in the current edition of Roberts Rules of Order shall govern the Council in all cases to which they are applicable, and in which they are consistent with these bylaws and any special rules of order the Council shall adopt.

#### **ARTICLE X: AMENDMENT OF BYLAWS**

- 10.1 PROCEDURE: The Council may prescribe, amend, and repeal bylaws governing the manner in which the business of the Council is conducted. The bylaws can be amended by a two-thirds vote of the Council provided that the proposed amendment has been submitted in writing to all members at least fifteen days in advance of the next regular or special meeting, and that a quorum is present.

#### **ARTICLE XI: INDEMNIFICATION OF DIRECTORS AND OFFICERS**

11.1 To the fullest extent permitted by law, and to the extent not covered by insurance, the Corporation shall indemnify, hold harmless, and pay on behalf of its Directors and officers, including former Directors and officers, for any and all claims and liabilities which any such Director may incur as a result of serving or having served as a Director or officer, or by reason of any action, incident, error, or omission committed as a Director or officer. In addition, the Corporation shall reimburse such Director or officer for reasonable attorneys' and legal assistants' fees and costs incurred in connection with any such claim or liability. Notwithstanding the foregoing, the Corporation shall not indemnify any Director or officer for any expenses incurred in relation to any claim or liability arising out of that Director's or officer's own willful misconduct, bad faith, gross negligence, conscious disregard for the best interests of the Corporation, recklessness, violation of criminal law (unless the Director or officer had reasonable cause to believe that his or her conduct was lawful or had no reasonable cause to believe his or her conduct was unlawful), as a result



of a final adjudication, or any transaction from which the Director or officer derived an improper personal benefit, either directly or indirectly.

**Welcome**

Dr. Chris Cogle began by welcoming members and guests, taking a moment to reaffirm the Council's mission to advise the state on ways to reduce cancer burden, and reviewing the day's agenda.

**Approval of Minutes**

Dr. Robert Cassel made a motion to accept the minutes. Dr. Clement Gwede seconded motioned to approve the minutes. The Council concurred with no objections.

**State of the State on Cancer**

Dr. Cogle presented a slide set from the 2018 CCRAAB Annual Report that illustrates the cancer burden in Florida. There was discussion regarding metrics on cancer incidences and deaths in Florida. High mortality rates in the Panhandle and other rural counties, likely influenced by social factors, were noted. In looking at south Florida counties, Dr. Erin Kobetz stated that looking at the smaller community level within counties could provide a better understanding of mortality.

Dr. Amy Smith discussed the pediatric cancer data and spoke to cancer clinical trials available for children in Florida.

There was discussion regarding the Florida Cancer Plan cancer screening goals. Megan Wessel stated that the American Cancer Society (ACS) recommends making an informed decision for prostate cancer screening, and that the ACS's colorectal cancer screening guidelines are currently being updated. Ms. Wessel will share these guidelines with the Council when they are available.

Dr. Cogle asked the Council to review the statement on prostate cancer screening recommendations from the Prostate Cancer Advisory Council (PCAC). He gave members the opportunity to provide comments, which will then be shared with PCAC.

**Florida DOH Updates by Dr. Celeste Philip & DOH Team**

Dr. Celeste Philip stated that several of the DOH cancer programs staff members had prepared updates to report the information requested for this CCRAAB meeting, and asked the staff participating by phone to begin their presentations.

Gregg Smith gave an update on the breast and cervical cancer early detection program. Mr. Smith said that the five- year CDC funding had been renewed, and that there will be a site in Orlando for the first time starting July 1, 2018.

There was discussion regarding the additional data needed to determine the number of underserved women who access breast cancer screening outside of the state's program. This issue was first brought up at the September 2017 meeting. The information has been difficult to find since September 2017 because of lack of data available from community charity groups. System (UDS) used by FQHCs and the Florida Association of Community Health Centers were suggested as potential sources for this data.

Felicia Dickey gave an update on the colorectal screening program. Ms. Dickey said they were in their third year of five-year funding and would be adding a new partner. Dr. Gwede asked if FQHC UDS screening numbers had been increasing. Ms. Dickey said yes. She added that the ACS and DOH have been working with groups around the state, sharing lessons learned by the program and holding several roundtables.

Sam Mooneyhan gave an update on the lung cancer screening education program. Mr. Mooneyhan explained that they are in the process of developing an invitation to negotiate. The project focus is looking at primary care that might not be aware of screening resources/facilities.

Mr. Mooneyhan also gave an update on the comprehensive cancer control program. He said the work of the regional groups is intended to be a complement to the Cancer Plan. Regional goals and priorities vary, as their plans are developed locally. They mainly focus on implementing low- or no-cost community interventions within the region given that only a small amount of funding is available for projects. Regions do not seem to be picking from Theme 5 of the Cancer Plan, but instead pick what impacts patients more directly using research that is already available. Mr. Mooneyhan will organize additional details to provide to the Council.

Bonnie Gaughan-Bailey gave an update on Cancer Centers of Excellence. Ms. Gaughan-Bailey said that there are no new applications in approximately two and a half years. Dr. Cassel asked about the five centers that initially applied but were not accepted. Ms. Gaughan-Bailey explained that the Cancer Center of Excellence Joint Committee comprised of CCRAB and BRAC members modified the training and research components, which should have made the designation more attainable, but none have applied. Dr. Cassel suggested that DOH staff reach out directly to the lead person on the applications from the centers that initially applied and ask them if they would like to apply again. Melissa Murray Jordan said that is something they could do. Megan Wessel suggested that it might also be helpful to go to the centers that have the designation to see what the benefits have been and what value it's adding. Dr. Cogle brought up that the Cancer Centers of Excellence program provides an accolade to centers who achieve its designation. However, the application is lengthy and requires significant time and effort to complete. He added that the designation is not tied to funding or other tangible advantage, which tilts the benefit:cost ratio towards cost. He suggested that the DOH consider adding funding or some other tangible advantage to reward current designees and entice new cancer centers.

Melissa Murray Jordan gave an update on the Palliative Care Ad Hoc Committee. She said the DOH released a report with the Committees findings and recommendations. Additionally, there is expected to be a new statewide effort on advanced care planning led by the Florida Hospital Association; a meeting is being planned for the summer.

### **2018 Legislative Update**

Representative Jamie Grant gave an update on the 2018 legislative session. He explained that this was a very unique year for the legislature given the balanced budget requirement, hurricane recovery, and then tragic high school shooting. Representative Grant also discussed issues that his committee and the legislature spent quite a bit of time on, including medical marijuana and opioids. He also explained the Health Information Exchange and its use during the last hurricane.

Heather Youmans gave an update on the American Cancer Society Cancer Action Network's (ACS CAN) 2018 legislative priorities and session outcomes. Although the Mary Brogan Breast and Cervical Cancer Screening Program received less money this year, but the funding for FY 2018-19 is in recurring dollars, which guarantees that funding will be included in next year's base budget. The James and Esther King Biomedical Research Program received \$10 million, and the Bankhead-Coley Cancer Research Program received \$13 million, with \$3 million earmarked for pediatric cancer through the Live Like Bella initiative. The state's tobacco prevention and education program was fully funded in accordance with the state constitution requirement. Ms. Youmans also noted the withdrawal of the proposed Constitution Revision Commission (CRC) proposal that would have moved funding away from the advertising component of the state's tobacco prevention program.

#### **Iowa Cancer Consortium Presentation by Kelly Sittig**

Kelly Sittig, Executive Director of the Iowa Cancer Consortium delivered a presentation regarding the Consortium's work.

#### **Florida Cancer Data Systems Update**

Dr. Philip introduced Ms. Tara Hylton and Mr. Gary Levin to provide an update on the Florida Cancer Data System (FCDS). FCDS is working with different programs to bring in different data to meet the needs for requests. The registry is linking screening data as far back as 2009 and adding HIV data. There was discussion regarding the addition of genetic information to the registry. The rulemaking process may not be necessary if the data acquisition manual can be updated to include this information. Ms. Hylton recommended convening a group of experts to advise on specific laboratory and biomarker data to include in the registry. Mr. Levin said that a large number of claims spanning a 4-year period had been received. These cases are being validated to see if all are Florida patients. VA data is being added to the registry as its completeness is confirmed given that some VA facilities are more complete in their reporting than others.

#### **Florida Biomedical Research Advisory Council (BRAC) Update**

Drs. Armstrong and Nowakowski gave an update on the state's cancer research programs' application number and funding rates. The bulk of applications for grants through the James and Esther King Biomedical Research Program and the Bankhead Coley Cancer Research Program have been for discovery research. There is a need to increase the quantity and quality of health disparities research applications. Although the King program received more funding than in previous years, the BRAC was still only able to fund the same number of projects. There is still a great need for additional funding in order to award the highly meritorious proposals. Awards are going to various institutions across the state, not just the larger centers.

#### **CCRAB Membership Update**

Dr. Cogle informed the Council that many of the Members' four-year appointments would be ending this Fall. He also said that the Chair and Vice Chair terms would be ending. The Council will vote on these positions at the end of the next CCRAB meeting. Dr. Cogle is interested in serving another term as Chair, and Dr. Gwede is interested in serving another term as Vice Chair. By June 19<sup>th</sup>, Council Members should let Bobbie McKee know if they would like to serve another term or step down, and if they would like to nominate anyone for Chair and/or Vice Chair.

**Next CCRAAB Meeting**

Dr. Cogle stated that the next CCRAAB meeting will be September or October 2018. He asked Council Members to inform Bobbie McKee of any dates that do not work for them by June 19<sup>th</sup>.

**Adjourn**

Dr. Cogle thanked everyone for participating. The meeting adjourned at 3:00 p.m. on May 18, 2018.

### 1. Florida Cancer Programming and Efforts Meeting

On July 31st, Drs. Christopher Cogle and Clement Gwede met in Tallahassee with Dr. Celeste Philip and the Florida Department of Health staff, Drs. Danny Armstrong and Richard Nowakowski, chair and vice chair of the Biomedical Research Advisory Council (BRAC), and Dr. Tom Stringer, chair of the Prostate Cancer Advisory Council (PCAC) to discuss the Department's cancer programs and grant aims, and opportunities to enhance collaboration. Specific updates will be provided at the CCRAB meeting on October 26th in Tampa.

### 2. HPV Vaccination

The Florida Department of Health with the American Cancer Society presented an important training webinar titled "Addressing HPV Vaccine Hesitancy and Myths" on July 25th. We look forward to working collaboratively with all stakeholders on this important issue.

## **Florida Cancer Plan 2015-2020**

### **Theme #1: Burden of Cancer (Data and Surveillance)**

- **Goal 1:** Expand the statewide data and surveillance program (FCDS) to facilitate accurate and timely cancer diagnosis collection and reporting inclusive of all Floridians
- **Goal 2:** Support the development of an outcomes-based statewide cancer integrated data repository to facilitate accurate identification of cancer patient treatments, outcomes and migration
- **Goal 3:** Link key screening, laboratory, and molecular cancer test results into the Florida cancer integrated data repository

### **Theme #2: The Best Defense is a Great Offense (Prevention & Early Detection)**

- **Goal 1:** Decrease the proportion of Floridians who use tobacco products, with particular emphasis on prevention of tobacco use amongst youth
- **Goal 2:** Promote healthy lifestyles and policies for Floridians to reduce the risk of cancer
- **Goal 3:** Increase the proportion of Floridians who receive appropriate cancer screenings

### **Theme #3: Improving Patient Outcomes with Treatment (Access to Care)**

- **Goal 1:** Support policies that will ensure health equity for all cancer patients and their caregivers
- **Goal 2:** Improve Floridian's access to high-quality, multidisciplinary oncology care
- **Goal 3:** Increase the number of Floridians with access to and participation in cancer clinical trials

### **Theme #4: Beyond the Cancer Diagnosis Survivorship (Survivorship)**

- **Goal 1:** Support education and awareness of cancer survivor needs in Florida
- **Goal 2:** Support policies that ensure all Floridians with cancer (and their caregivers) have access to resources that provide quality of life during and after therapy
- **Goal 3:** Support policies that ensure all Floridians with incurable cancer have access to resources that provide dignified end of life care

### **Theme #5: Florida as a Cancer Care and Research Destination**

- **Goal 1:** Invest in Biomedical research – In Florida – For Floridians
- **Goal 2:** Support the development of a state biomedical workforce pipeline (STEMS K-12 and beyond)
- **Goal 3:** Facilitate Florida-based Telemedicine for genomics and other advanced cancer research analytics and high-quality care
